Sub-processors that provide contract staff. Customer data and personal data may be visible or is required for work.

#### **Subsidiaries**

Subsidiaries and affiliates are companies where Krones holds most of the shares. In all such cases, customer data or personal data resides only on systems which are subject to Krones policies and supervision.
